



INTERNATIONAL TRANSACTIONS COMPLIANCE NOTICE

(CAGE 1S5X8)

As a U.S. based company, Crestwood Technology Group, LLC DBA Blue Raven (“Blue Raven”) is subject to U.S. laws and regulations as are all orders applicable to Blue Raven’s business activities, including those related to the international sale and export of its products. Blue Raven is also subject to the laws of foreign countries in which it decides to do business and further adheres to the U.S. Customs and Border Protection’s Customs Trade Partnership Against Terrorism (CTPAT) program. Blue Raven’s distributors have separate and independent obligations under these same laws. All Blue Raven official representatives, agents, suppliers, customers, or other third parties acting as intermediaries for the ultimate end-user must be knowledgeable regarding, and remain in full compliance with, all applicable export and import laws, regulations, sanctions, embargoes, and policies, including, but not limited to, securing all clearances, export and import licenses, or exemptions therefrom, and making all required filings with appropriate governmental bodies. The items may not be resold, transferred, or otherwise disposed of, to any other country or to any person other than the authorized ultimate consignee or end-user, either in their original form or after being incorporated into other items, without first obtaining approval from the U.S. government, or as otherwise authorized by U.S. law and regulations.
