



FLOWDOWN PROVISIONS (FAR-DFARS) FOR ORDERS UNDER U.S. GOVERNMENT CONTRACTS

The Federal Acquisition Regulation (FAR) and Defense Federal Acquisition Regulation Supplement (DFARS) clauses referenced below, and any corresponding notes, are incorporated herein with the same force and effect as if they were given in full text, and are applicable, during the performance of this Contract. When a clause uses a word or term that is defined in the FAR or DFARS, the word or term shall have the same meaning as in the definition in FAR 2.101, DFARS 202.101 in effect on the date of this Contract unless (a) a different definition is expressly set forth in this Contract; or (b) the part, subpart, or section of the FAR, DFARS, or supplement where the clause is prescribed provides a different meaning; or (c) the word or term is defined in FAR Part 31, for use in the cost principles and procedures. If the date or substance of any of the clauses listed below is different than the date or substance of the clause incorporated in the Prime Contract referenced by number herein, the date or substance of the clause incorporated by said Prime Contract shall apply instead. If corresponding FAR and DFARS clauses are referenced, DFARS has first precedence, followed by the FAR. Any reference to "Disputes" clause shall mean the "Governing Law, Jurisdiction and Disputes" clause of the Terms and Conditions of Purchase.

In all clauses listed herein, the terms "Government," "Contracting Officer" and "Contractor" shall be revised to suitably identify the contracting parties herein and affect the proper intent of the clause or provision except where further clarified or modified below. Thus, the term "Government" shall mean "Crestwood Technology Group, LLC and/or Triman Industries, Inc, collectively DBA Blue Raven", where applicable, "Contract" means this order, "Contractor" means Seller, and "Subcontract" means any contract placed by Seller or lower-tier subcontractors under this Contract. The terms "Government" and "Contracting Officer" do not change (a) in references to Government Property (b) when a right, act, authorization, or obligation can be granted or performed only by the Government or the Contracting Officer; (c) when access to proprietary financial information or other proprietary data is required; (d) when title to property is being transferred directly to the Government; (e) in patent rights clauses, if any; (f) where specifically modified below and (g) in DFARS 252.227-7013, 252.227- 7015, and 252.227-7037.

Seller shall, at the request of Blue Raven, accept amendments to this Contract to incorporate additional clauses and provisions herein or to change clauses and provisions hereof, as Blue Raven may reasonably deem necessary in order to comply with the clauses and provisions of the applicable Prime Contract or with the clauses and provisions of amendments to such Prime Contract.

Seller acknowledges that FAR Subpart 9.5, Organizational and Consultant Conflicts of Interest, governs Work performed under this Agreement. Seller represents and warrants that there are no actual, potential, or perceived conflicts of interest associated with its Work for Blue Raven.
